

## FOUR YEAR ROAD PLAN

RE: FOUR YEAR ROAD PLAN (AMENDED)

Supervisor Chad Coffey moved adoption of the following Four-Year Road Plan (amended):

### UNION COUNTY FOUR-YEAR ROAD PLAN JANUARY, 2016

PREAMBLE. As required by Section 65-7-117, Mississippi Code of 1972, as amended, as a unit system county, each supervisor must annually inspect "every road and bridge in the county", file a report under oath together with recommendations for a four-year plan, and the entire board must annually adopt a four-year plan for maintenance and construction. Since effective date of the statute, the supervisors of this county, as a group, have annually inspected each road and bridge in the county, filed the sworn report, and collectively recommended and adopted a four-year plan. As authorized by said statute, the previously amended four-year plan is hereby amended and replaced by the following plan, with two caveats: (1) many uncontrollable factors (floods, freezing, logging, etc.) make any long range plans subject to almost certain change; and (2) this board goes out of existence the first of January 2020, and other than making the budget and levy for the first nine months of the new board, has no authority to make plan commitments beyond that date.

PAVING. The board plans the following DBST projects and Reseal:
